Dear Messrs. Francis and Carroll:

The U.S. Environmental Protection Agency wishes to thank you for your recent comments, dated May 14, 2018, on the Agency's proposed revisions to the Interim Final EPA Region 4 Consultation Policy Standard Operating Procedures (SOP).

The EPA takes seriously its responsibility to engage in tribal consultation, and is endeavoring to improve that engagement both internal and externally. Various staff and management personnel, both within the Region and at the Office of International and Tribal Affairs, are involved in the Agency's decision-making process as to whether a matter is appropriate for consultation and/or the adequacy of any such consultation. To the extent that the proposed SOP is unclear as to these roles, the Region will consider further revisions to the SOP.

The EPA appreciates USET Sovereignty Protection Fund's suggestion that the EPA more fully engage with tribes as what issues may be appropriate for consultation. EPA's policy is to offer consultation on actions and decisions which may affect tribal interests. The EPA believes that tribes have an important role to play in assisting the Agency in identifying those actions and decisions. Therefore, Region 4 intends to continue its dialogue with Region 4 tribes to identify such matters in an early and meaningful manner, and to improve its internal communications about such matters. In addition, as noted in both the EPA Consultation Policy and the Region's SOP, tribes may request consultation on EPA actions and decisions.
