**Subject:** DOI Reorganization

As many of you are aware, Secretary Zinke has proposed to reorganize the Department of the Interior to improve the efficiency, effectiveness, and accountability of the Department of the Interior by reorganizing certain agency functions and bureaus. I am attaching the maps that have been circulated for review (and appear on the below website). You should understand that the plans for the reorganization can best be described as "fluid". The Administration is very much relying on Tribal Leaders to be forthcoming with their ideas and recommendations.

At some point in the very near future, Tribal Consultation sessions will be held through-out Indian Country to allow Tribal Leaders to offer suggestions, comments, and recommendations for reorganizing. I would strongly urge you to attend one or more of the sessions that are held. Further, I would encourage you to reach out to your fellow Tribal Leaders and discuss any ideas you may have. At the heart of this effort is improving the efficiency, effectiveness, and accountability of the Bureau of Indian Affairs and other DOI Agencies. As I understand there are **no** restructuring options that are off the table, so your participation is paramount to assure any specific limitations, recommendations, or concerns you have are made of record.
