WHEREAS, the United Southeastern Tribes, Inc. Executive Committee, has instructed that this contract proposal be prepared, and;


WHEREAS, the United Southeastern Tribes, Inc. intends to sponsor the ONAP Contract through a joint arrangement with other agencies, and;



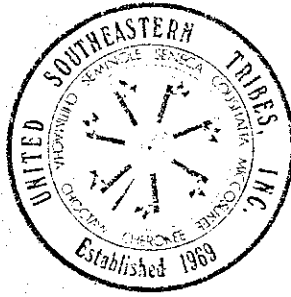


