Request for Waiver - Housing Improvement Program - American Rescue Plan

I. Introduction

On March 11, 2021, the Congress enacted the American Rescue Plan (ARP) Act which appropriated \$100,000,000 to the Bureau of Indian Affairs (BIA) for the Housing Improvement Program (HIP). In an effort to provide maximum flexibility to Tribal governments and individual Indians as they continue to navigate the coronavirus pandemic, the BIA requests a waiver of the HIP regulations outlined below. Such a waiver would apply only to the expenditure of ARP HIP funds and would remain effective until December 31, 2023.

II. Authority

The Assistant Secretary – Indian Affairs (AS-IA) is authorized ¹ to waive any regulation in 25 C.F.R. Chapter 1 when a waiver is permitted by law and he finds that such waiver is in the best interest of the Indians. ² While the regulation is silent as to the process for making a determination as to the best interest of the Indians, the AS-IA has generally determined that a waiver is in the best interest of the Indians where such waiver is applied consistently across Indian Country and is consistent with the principle of Tribal self-governance. Further, evidence that Indian Affairs' policy goals would be achieved by waiving a particular regulation supports a determination that such waiver is in the best interest of the Indians.³

III. Proposed Waiver

Waiver of the following regulations will allow BIA and Tribal governments to exercise greater flexibility in program execution and provision of services in response to the COVID-19 pandemic:

The BIA asserts that waiver is permitted by law and is in the best interest of the Indians as required under the secretarial waiver authority at 25 C.F.R. § 1.2. Additionally, the BIA asserts that waiver is consistent with the intent and purpose of both HIP and ARP. Upon approval of this request, the BIA will initiate appropriate guidance to its Regions and Tribal governments regarding the waiver.
