Dear Tribal Leader,

It is my honor to invite you to a virtual Listening Session with the Institute of Museum and Library Services (IMLS) on **Wednesday**, **October 6**, **2021**. We continue to seek your recommendations and feedback on ways to engage and support Tribal governments and institutions. For reference, here is our Tribal Consultation Plan.

IMLS is a federal agency that advances and supports museums, libraries, archives, and related organizations through grantmaking, research, and policy development. We provide grant opportunities, including grant programs specifically available to Tribes.

## Audience:

Listening to Tribal comments and perspectives of individuals is a priority for IMLS. Anyone is welcome to participate, though anyone speaking on behalf of the Tribe must be either a Tribal Leader or designated proxy. To create an opportunity for anyone who wishes to share their thoughts, we plan to utilize small group breakout sessions within the larger Listening Session. I invite you to pass this information along to Tribal leadership and staff who you feel would be appropriate to attend, such as those working with your Tribe's library, museum, archives, cultural centers, or related grants. Please be aware that there may also be others in attendance, including representatives of organizations that serve Native interests.
