	Roundtable #4: Rebuilding Tribal Homelands and Strengthening Economies Tribal Nations have spent the last several decades rebuilding their homelands and economies as a direct result of centuries of federal policies of assimilation and termination. During this roundtable, participants will discuss opportunities and challenges experienced as part of their respective rebuilding efforts, including, but not limited to, Fee-to-Trust land acquisitions, the 2021 Infrastructure and Jobs Act, broadband deployment, energy independence, and employment-attracting and retaining personnel.

	Roundtable #6: Examining the ISDEAA Policy Era and Visioning for the Next Era Prior to the passage of the Indian Self-Determination and Education Assistance Act (ISDEAA) in 1975, federal Indian policies sought to assimilate and terminate Tribal Nations and indigenous people. For 47 years, Tribal Nations have utilized this law to advance beyond the confines of paternalistic and antiquated processes, models, and structures. While progress has been made, there is more growth and evolution that must occur. During this session, participants will explore the pros and cons of ISDEAA and discuss what the next policy era might look like.
