

Important Updates from Treasury's Office of Recovery Programs

Last week the U.S. Department of the Treasury (Treasury) Office of Recovery Programs issued several updates regarding upcoming deadlines for application submissions, reporting deadlines, and Office Hours for technical assistance. Additionally, as a reminder, Treasury will be hosting a Tribal consultation on its Strategic Plan on **Tuesday, December 6, 2022 at 3:00pm ET**. Upcoming Deadlines

Saturday, October 15, 2022 – [Capital Project Fund](#) (CPF) application submission deadline by **2:59am CT/3:59am ET**.

- Every Tribal government has been allocated \$167,504 in CPF funding. To learn more about the program, please refer to the Treasury's [overview](#) of the CPF for Tribal governments and Treasury's [CPF Guidance for Tribal governments](#) for more information regarding the access and use of these funds. Treasury has also [published](#) the awarded CPF projects for Tribal governments, with project descriptions, to its website to provide examples on potential uses of funds to Tribal governments as they apply to CPF.

Monday, October 17, 2022 – [Emergency Rental Assistance](#) (ERA1) Cycle 7 quarterly report due.

- The next quarterly report is due on October 17, 2022 within the Treasury portal for all ERA1 Tribal grantees. Group A's period of performance end date was **September 30, 2022** and closeout activities and a final report are due by **January 30, 2023**. Group B received reallocation funding with a performance end date of **December 29, 2022**. Group B must complete closeout activities and submit a final report by **April 28, 2023**. Payment processing for obligations, or approved ERA1 applications (for rent, utilities, or other allowable expenses incurred prior to the period of performance end date), may occur until the grant closeout.

Wednesday, October 19, 2022 – Beginning of [Homeowner Assistance Fund](#) (HAF) Office Hours.

- Treasury will begin hosting support sessions to provide opportunities for Tribal Nations and Tribal Designated Housing Entities (TDHEs) to ask questions about the HAF program and provide assistance in completing and submitting their HAF plan.
- A Compliance and Reporting Support Session is scheduled for **Wednesday, October 19, 2022 at 3:00 pm ET**. This session is being held for all Tribal Nations to learn more about Treasury's reporting portal and to provide guidance on how to submit the HAF quarterly and annual reports (due **November 15, 2022**). - Treasury will be hosting weekly Office Hours every Wednesday beginning **October 25, 2022 at 3:00pm ET**. Treasury staff will be available to provide assistance to Tribal Nations that need support to submit a HAF report and/or a HAF plan. Please [click here](#) to register to these Wednesday sessions.
- The HAF Annual Performance Report is due **Tuesday, November 15, 2022**.

Wednesday, October 26, 2022 from 1:00pm to 4:00pm ET – [Treasury Tribal Advisory Committee](#) (TTAC) Meeting.

- The [TTAC Public Meeting](#) will be held in person at the Treasury Building (located at 1500 Pennsylvania Avenue, NW in Washington, DC) and is open to the public. Written comments in response to the business of the TTAC can be submitted to TTAC@treasury.gov **no later than 15 calendar days** before the Public Meeting to be considered by the TTAC. - Treasury is also seeking nominations to appoint one member to the TTAC. Please send applications or recommendations to TTAC@treasury.gov, with a subject line “Treasury Tribal Advisory Committee member application or recommendation.” Treasury will accept self-nominations or recommendations to the TTAC until **November 18, 2022**. Tuesday, November 1, 2022 – [Local Assistance and Tribal Consistency Fund](#) (LATCF) submission deadline by 2:59am CT/3:59am ET.

- The American Rescue Plan Act allocated \$250 million for the LATCF for eligible Tribal governments for fiscal years 2022 and 2023. Under this program, Tribal recipients have broad discretion on uses of funds, similar to the ways in which they may use funds generated from their own revenue sources. Recipients should review the [LATCF guidance](#) to learn more about eligibility requirements, eligible uses, and other important information related to the fund such as the application of the Build America, Buy America Act (BABA).
- Eligible Tribal governments may review their specific allocation under the program and request payment of their allocation through the [Treasury Submission Portal](#). Recipients will be required to complete payment information, sign program terms and conditions, and submit a certification regarding the Tribal Nation’s economic conditions. Treasury has published a [summary of the methodology](#) used to determine allocations for Tribal governments and other materials, including a summary of Tribal consultations, can be viewed on the [LATCF homepage](#).
- **If an eligible Tribal government does not complete an LATCF application by the November 1, 2:59am CT/3:59am ET deadline they will not be eligible for either the first or second payment under the LATCF.**

Monday, October 31, 2022 by 11:59pm ET – [State Small Business Credit Initiative](#) (SSBCI) application submission deadline.

- To participate in the SSBCI program, Tribal governments were required to submit a [Notice of Intent \(NOI\)](#) to Treasury by December 11, 2021. To view the SSBCI Capital Program Policy Guidelines that were updated on October 7, 2022, please [click here](#).
- The deadline to apply for the SSBCI Technical Assistance (TA) Grant Program is **Friday, December 9, 2022 by 11:59 pm Eastern Time**. An SSBCI TA Application Template has been posted to [Treasury’s Website](#) along with [supporting documents](#). Additionally, a new [Frequently Asked Questions](#) document has been added regarding a streamlined approach for applying for SSBCI TA Grant Program awards of \$250,000 or less and disbursements of TA Grant Program awards.
