Dear Chairman McGovern and Ranking Member Cole,

On behalf of the United South and Eastern Tribes Sovereignty Protection Fund (USET SPF), we are grateful that H.R. 759, the Ysleta del Sur Pueblo and Alabama-Coushatta Tribe of Texas Equal and Fair Opportunity Settlement Act, unanimously passed the House earlier in the 116th Congress. While the Senate has yet to act on this important legislation, a bipartisan group of Representatives, including Representative Escobar, are seeking to add the language to H.R. 6395, the William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021. We respectfully request your support for Amendment 681 offered by Representatives Escobar, Babin, Gallego, Hurd and Cardenas.

USET SPF is a non-profit, inter-tribal organization advocating on behalf of 30 federally recognized Tribal Nations from the Northeastern Woodlands to the Everglades and across the Gulf of Mexico¹. USET SPF is dedicated to promoting, protecting, and advancing the inherent sovereign rights and authorities of Tribal Nations, and assisting our membership in dealing effectively with public policy issues.

In March 2019, during the USET SPF 2019 Impact Week Meetings, we passed a resolution in support of H.R. 759 to ensure the protection of Tribal sovereignty and self-governance; a copy of the Resolution is attached hereto as Exhibit 1. The passage of H.R. 759 is vital to the continued economic development and health of the Ysleta del Sur Pueblo and Alabama-Coushatta Tribe of Texas. It is estimated that the total economic impact for the passage of H.R. 759 would be \$645 million in and around El Paso and Livingston, Texas. At a time when the novel coronavirus has caused major economic harm in Indian Country and in the Tribal Nations' surrounding communities, the passage of H.R. 759 would facilitate the hiring and retention of well over 1,700 jobs at no cost to the federal government.

As you know, there is precedent for the consideration of Tribal bills in the annual National Defense Authorization Act, including several provisions included as recently as last year. H.R. 759 has wide-spread,
