


# **Rural Development Structure**

# **Types of Funding and Funding Cycles**

### **Types of Funding**

- Primarily Loans Direct & Loan Guarantees
- Grants are Great,... and <u>Limited!</u>
- Depends on the Program and Allocation

### **Funding Cycles**

- Operate on Fiscal Year (October 1 September 30)
- Funding depends on budget
- Programs & State Offices receive funding allocation differently
- Pooling of funds and reallocation

## Rental Housing for Individuals and Families

#### **Multifamily Housing Loan Guarantee Program**

- Qualified private-sector lenders provide financing to qualified borrowers. Eligible borrowers include Federally recognized Indian tribes.
- Min. Term: 25 yrs.; Max Term: 40 yrs.; Interest rate fixed for life of the loan guarantee.
- Housing must be in eligible area—Tribal trust lands are eligible.
- Rent must be affordable (low and moderate income).
- Benefits: USDA guarantees up to 90% of loan (97% for non-profits)—attractive to lenders, cap on rent.


# **Community Facilities Programs**

- Program can be used to fund community centers,
   health care, public safety and educational facilities
- Eligible applicants include Federally Recognized Tribes
- Project must be in eligible area—most Tribal Trust lands are eligible
- <u>Direct Loans</u>, Loan Guarantees and small grants
   Low interest, long term financing. 40 Years or useful life. Interest rate is 3.75% (thru 6/30/23).
- TCU Initiative Grants for 1994 Land Grant Institutions
- CF Technical Assistance and Training Grants

# Other Funding Related to Housing - RCDI Grant Rural Community Development Grant



Provides financial and technical assistance to develop the capacity and ability of eligible applicants in housing, community facilities, or community and economic development. May be used to provide homeownership education. Dollar for dollar match requirement.

<u>Intermediary</u>: A private, nonprofit or public (including tribal) organization. Must have been organized for a minimum of 3 years. Expertise in providing technical assistance to the types of recipients in their proposal.

Recipient: The entity that receives the technical assistance from the intermediary. Eligible recipients are nonprofit organizations, low-income rural communities or federally recognized tribes.

Beneficiary: Entities or individuals that ultimately receive benefits from technical assistance provided by the recipient.

### Rural Business Development Grant (RBDG) Basics

- RBDG is a grant program that supports:
  - Capitalization of a revolving loan fund
  - Technical Assistance
  - Feasibility Studies
  - Purchase of Real Estate (i.e., business incubator)
  - Purchase of Equipment
- All assistance to a business is <u>indirect</u>
- Assistance must be provided to a "Small and Emerging Business"
  - "Any private business which will employ 50 or fewer new employees and has less than \$1 million in projected gross revenues"

### RBDG – Good to Know

- Grants customarily less than \$500,000 (not statutory)
  - Average tribal grant in FY 19 was ~ \$140k (27 grants)
  - Largest FY 19 Grant \$499k
  - Regular program grants are more competitive & typically smaller awards
- Matching funds are not required
- Leveraged funding is a scoring criteria
  - This makes a huge difference in the regular program
  - Not as critical with tribal funding
- Must assist businesses in rural areas of 50,000 or less
- Enterprise and Opportunity type projects

# Intermediary Relending Program (IRP)

- Direct loan made to Intermediary
- Terms: 30 years 1% fixed interest rate
  - 3-year deferral period is available
- Max loan: Up to \$1 million for the first financing
  - Total aggregate debt cannot exceed \$15 million
- Loan funds are relent to businesses (Ultimate Recipients)
  - Maximum Loan to Ultimate Recipient is currently \$400k (or 50% of loan to relender)
  - Terms of loans are negotiated between parties
  - Initial round is concurred on by Rural Development
    - Administrative review only
    - Agency does <u>not</u> underwrite files
- The spread between the rate charged the Intermediary (1%) and that charged to the Ultimate Recipients is used to help pay administrative costs

### Rural Microentrepreneur Assistance Program (RMAP)

- The revolving loan fund portion of this program works like the IRP with the following differences:
  - Max loan to intermediary is \$500,000 (min loan = \$50,000)
  - Max loan to Ultimate Recipients is \$50,000
  - Total aggregate debt to MDO is capped at \$2.5 million
  - Ultimate Recipient must be "microenterprise" defined as a business with a max of 10 employees
- Max term to intermediary is 20 years with an interest rate of 2%
- Loan Funds are awarded in conjunction with a grant
  - The grant will fund technical assistance and pay administrative costs
  - 15% matching funds requirement
- Must assist microenterprises in rural areas of 50,000 or less
- Applications accepted year round

### **Business and Industry Guaranteed Loans (B&I)**

"B&I" Purpose: To improve, develop or finance business, industry & employment and improve the economic & environmental climate in rural communities.

- Rural = 50,000 or less
- Federally Recognized Tribes are eligible applicants
  - Tribally owned businesses are eligible
  - Businesses owned by tribal members are eligible
  - Nonprofits, cooperatives and public bodies are eligible
- 80% Maximum Guarantee for loans in FY 22
  - Maximum guarantee rates will be updated in the Federal Register
  - Certain exceptions
- Guarantee Fees & Equity Requirements
- Included in OneRD Guarantee Process

# RD Programs for 'Agriculture' Producers

### Value Added Producer Grant Program (VAPG)

- 50% Matching funds required (dollar for BTRC1)ar)
- Maximum Awards: *Planning* \$75,000 & *Working Capital* \$250,000
- Examples of planning activities include conducting feasibility studies and developing business plans for processing and marketing the proposed value-added product.
- Examples of working capital expenses include processing costs, marketing and advertising expenses, some inventory and salary expenses.



# RD Programs for 'Agriculture' Producers

### Rural Energy for America Program (REAP)


- Provides grants & guaranteed loans for <u>agricultural producers</u> & <u>rural small</u> <u>businesses</u> to purchase & install renewable energy systems & make energy efficiency improvements.
- Grants can pay up to 50% of total project costs
  - \$2,500 min and \$1M for renewable energy system grants
  - \$1,500 min and \$500,000 max for energy efficiency grants
  - Grant requests of \$20,000 or less will automatically compete in a set-aside for small grants when applicable.
- Loan Guarantees can pay up to 75% of total project costs
  - Term not to exceed 40-years

- No match required

# Financing Water & Waste Disposal Infrastructure

#### Water & Waste Disposal Loan & Grant

- Funding for clean and reliable drinking water systems, waste disposal and storm water drainage for household and businesses in eligible areas.
- Project must be in eligible area most Tribal Trust lands are eligible.
- Low interest loans available
  - Term of the loan: Useful life of the facilities financed up to 40 years
- If funds are available, a grant may be combined with a loan to keep user costs reasonable.
- SEARCH and Pre-development & Planning (PPG) Grants

# Water & Waste Disposal Grants to Alleviate Health Risks "Native American 306c Set Aside"

- Funding for construction of basic water and/or waste disposal systems.
- Eligible applicants include Federally recognized Indian tribes.
- Project must be in eligible area most Tribal Trust lands are eligible.
- Applicants must meet per capita income and unemployment rate guidelines.

# Financing Water & Waste Disposal Infrastructure

#### **Emergency Community Water Assistance Grants**

- Water transmission line grants up to \$150,000 to construct waterline extensions, repair breaks or leaks in existing water distribution lines, and address related maintenance necessary to replenish the water supply
- Water source grants up to \$1,000,000 for the construction of new wells, reservoirs, transmission lines, treatment plants, and/or other sources of water

#### **Rural and Alaska Native Villages Grants**

 Program helps remote Alaska Native villages provide safe, reliable drinking water and waste disposal systems for households and businesses

### ReConnect Broadband Pilot & Telecom Programs

#### **ReConnect Broadband Pilot Program**

- Round 1 Closed \$607.8 Million
- Round 2 Closed \$808.4 Million (including CARES Act funding)
- Round 3 Closed \$1.67 Billion



# Section 22001 Program Forgivable Loans for Clean Energy Projects

# **ACE – ADDITIONAL FUNDING FOR ELECTRIC LOANS FOR RENEWABLE ENERGY.** (partially forgivable 317 Loans)

- Amount \$1 Billion
- Purpose for cost of loans under Sec 317 (which finances wind, solar, hydropower, biomass, or geothermal sources) including projects that store electricity in support of 317 technologies
- Eligibility Renewable generation for resale to rural and nonrural residents
- Forgiveness Up to 50% of the loan may be forgiven
- Loan Interest Rate Municipal Rate
- Waiver Secretary shall establish criteria for going above 50% forgiveness

# **Section 22004 Program Funding**

\$9.7 billion dollars in Budget Authority for the long-term resiliency, reliability, and affordability of rural electric **systems** to achieve the **greatest reduction** in CO<sub>2</sub>, methane and nitrous oxide emissions.

Eligibility – Electric Cooperatives that are or have been RUS borrowers or electric cooperatives serving a predominantly rural area or a wholly or jointly owned subsidiaries of such cooperatives.

#### **Activities Supported (per the statute)**

- the purchase of renewable energy
- renewable energy systems
- zero-emission systems
- carbon capture and storage systems to deploy such systems
- energy efficiency improvements to generation & transmission systems of eligible entities

#### **Permitted Use of Funds (per the statute)**

- · loans and modifications of loans
- · the cost of loans and modifications
- grants
- other financial assistance

#### **Limitations (per the statute)**

- no entity may receive more than 10 percent of the total amount of the budget authority
- grants not to exceed 25% of total project costs

# **Substantially Underserved Trust Areas Provision (2008 Farm Bill)**

Programs covered: Electric Loans, Telecom and Broadband Loans, WEP Loans and Grants and High Energy Cost Grants

 At the discretion of Administrator, RUS can modify certain loan terms or application requirements:



- Interest rates as low as 2%, extended amortization period, and/or priority processing
- Waiver of certain documentation requirements regarding non-duplication of service
- Waiver of matching funds or credit support requirements for loans
- Providing the highest priority for funding to eligible projects that will serve trust areas
