I am writing to inform you of the procedural requirements for one-time Division of Wildland Fire funding requests under PL93-638 Grants. These procedures aim to streamline the funding process and ensure transparency and accountability in the allocation of funds for Tribal projects.

PL93-638, Grant(s): Under PL93-638, any official correspondence from Tribal leadership requesting funding should be accompanied by the following documents:

- Tribal Resolution Number: Please include a Tribal Resolution number along with the official request. This number will help in tracking and processing your funding request efficiently.
- Copy of Tribal Resolution: Attach a copy of the Tribal Resolution to your request, indicating the Tribe's approval and endorsement of the proposed project. This resolution serves as an official confirmation of the Tribal Council's support for the project.
- Statement of Work: Provide a comprehensive and detailed Statement of Work (SOW) that outlines the project's objectives, activities, deliverables, and timelines. This should highlight the potential impact of the project on your Tribal community and its environmental implications.
- Budget and Budget Narrative: Include a well-prepared budget for the proposed project, indicating the estimated costs for each activity. Additionally, provide a budget narrative that justifies the expenses and explains how the funds will be utilized effectively and efficiently.

Kindly address the official correspondence to the appropriate line official with a carbon copy to the Division of Wildland Fire Management - Eastern Region, also ensure that the copies of all relevant documents are enclosed.

We emphasize the importance of submitting complete and well-documented proposals. This will enable our team to efficiently review and process your funding requests, ensuring that they are given the careful attention they deserve.

## **INTRODUCTION**

The <Tribe> (TRIBE) <Tribal Program> (<TRIBAL PROGRAM>) would like to submit a one-time funding request for the purchase of capitalized equipment. <TRIBAL PROGRAM> is responsible for enhancing and maintaining TRIBE forests within our Tribal Reserve and possessory holder landscape to support various management plans in order to address; natural resource protection, woodland/habitat/ecosystem enhancement, reduction of hazardous fuels in wildland/urban interface (WUI), the protection of culturally significant values, and other associated management directions and planned activities. However, our program has limited staff and a lack of appropriate tools which constrains our ability to efficiently manage our natural resources and protect out culturally significant values. The purchase and use of a highly efficient mechanical fuels treatment apparatus would enable our program to increase project production rates which would reduce overall project costs.

## **SCOPE OF WORK**

The <TRIBAL PROGRAM> plans to collaborate with the <Agency/Region> – Fire and Aviation Management (<AGENCY/REGION>) program in the completion of WUI mechanical fuels reduction, forestry development, natural resources, and prescribed fire treatments found in/adjacent to Tribal Reserve;

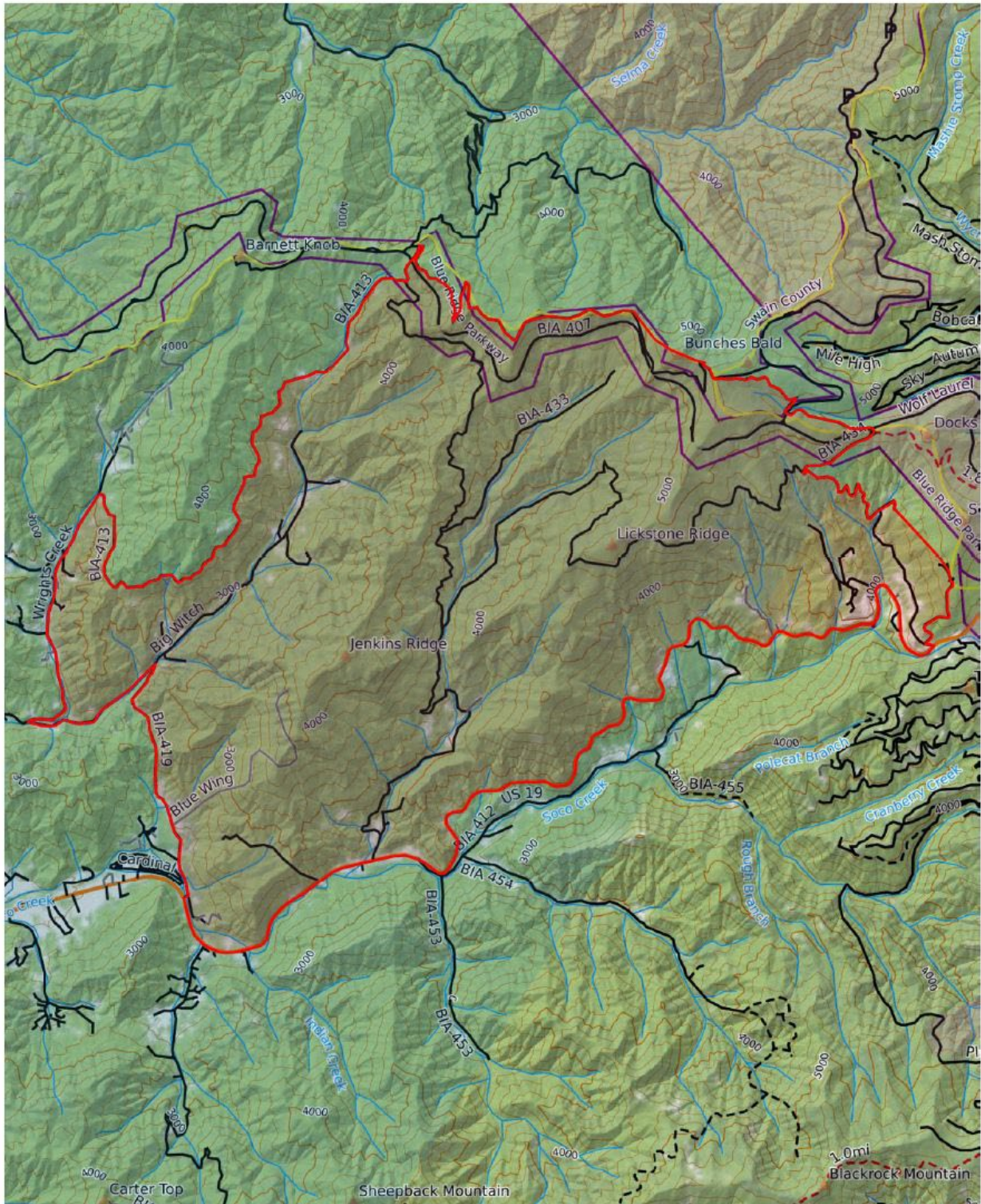
Project implementation is planned for 01OCT2020 thru 30SEP2023. The intent of these hazardous fuels reduction treatments is to create fuel breaks and reduce fuel loadings throughout the project area. Linear fuel break widths will vary and large concentrations of fuel within the fuel breaks will be treated to reduce fuel loadings to historical conditions. Mid story canopies will also be treated and standing timber will be spaced an average of 40 feet between stems, creating an open, park like appearance. In the event of a wildfire, these areas would provide defensible control area in/adjacent to WUI for fire suppression resources. Post treatment of the area will be maintained by prescriptive fire and mechanical treatments to promote regeneration of culturally significant timber species and plant habitat resulting in a holistic natural resource management approach.

Utilizing this equipment would cut project cost and increase production rates in relation to a twenty (20) person hand crew by reducing the amount of personnel associated with project implementation and reducing overall project duration. There is a substantial upfront cost associated with this purchase, however within a short period of time the savings incurred would pay for that initial cost.
