WHEREAS,	Senator Byron L. Dorgan served as United States Senator from North Dakota for eighteen years from
	1992 to 2010, after serving six terms in the U.S. House of Representatives; and

WHEREAS,	Senator Dorgan dutifully served on a number of Senate Committees including, the Committee on
	Appropriations, the Committee on Commerce, Science and Transportation, the Committee on Energy and
	Natural Resources, and the Committee on Indian Affairs; and

	American Indians and Alaska Natives; and

WHEREAS,	Senator Dorgan has time and time again fought for the interests of Indian Country including, but not limited
	to, the Tribal Law and Order Act, Indian Energy Development, Water Rights Settlements and Tribal
	provisions within the National Health Care Reform Legislation, Transportation and Education Laws; and

WHEREAS,	Senator Dorgan has worked throughout the years with Indian Tribes to achieve the Indian Health Care
	Improvement Act reauthorization. Currently, the Indian Health Care Improvement Act is the closest its
	ever been to being reauthorized and signed into law, thereby elevating the health status of American
	Indian/Alaska Native people; therefore, be it
