USET Resolution No. 2014:005

RECOGNIZING AND COMMENDING THE MISSISSIPPI BAND OF CHOCTAW INDIANS CHOCTAW CENTRAL HIGH SCHOOL SOLAR CAR TEAM

WHEREAS, United South and Eastern Tribes Incorporated (USET) is an intertribal organization comprised of twenty-six (26) federally recognized Tribes; and

WHEREAS, the actions taken by the USET Board of Directors officially represent the intentions of each member Tribe, as the Board of Directors comprises delegates from the member Tribes' leadership; and

WHEREAS, the Mississippi Band of Choctaw Indians (MBCI), being longtime members of USET and having a delegation of representatives at this Annual Meeting; formally requests recognition by USET of the outstanding accomplishments of the Choctaw Central High School (CCHS) Solar Car Team currently competing in the Bridgestone World Solar Car Challenge in Australia; and

WHEREAS, the CCHS Solar Car Team, having won the national Winston Solar Car Challenge in 2010 and in 2012, is the only high school team to compete in the global Bridgestone World Solar Car Challenge this year and holds the distinction of being the only Native American team to ever compete in the Challenge; and

whereas, the CCHS Solar Car Team's objectives are: 1) to find a clean air alternative to the dependence on fossil fuels, 2) to increase student knowledge in the fields of science, physics, math and engineering and 3) to serve as an example for native youth on the possibilities resulting from teamwork and unity; and

WHEREAS, exploration of the uses of solar energy shows respect to Mother Earth and its utilization by native people could reduce greenhouse gases that contribute to global warming, and provide a cleaner and possibly more affordable alternative for providing energy in Indian Country and beyond; and

WHEREAS, the CCHS Solar Car's voyage to the Bridgestone World Solar Car Challenge was funded through a concerted effort by the CCHS students, parents, school officials, Tribal members, and with the monetary and moral support of the Choctaw Tribal Council, and Tribal Chief Phyliss J. Anderson; and

WHEREAS, the CCHS Solar Car team is comprised of the following exemplary MBCI Tribal member students:

WHEREAS,

in December 2010, the United States recognized the rights of its First Peoples through its support of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), whose provisions and principles support and promote the purposes of this resolution; therefore, be it

the USET Board of Directors recognizes and commends the members and mentors of the Choctaw Central High School Solar Car Team of the Mississippi Band of Choctaw Indians for their successes and outstanding accomplishment in representing their families, Tribe, country, and native peoples in the Bridgestone World Solar Car Challenge in Australia.
