## **USET Resolution No. 2014:008**

# ESTABLISHING A WORKING PARTNERSHIP WITH THE MINNESOTA AMERICAN INDIAN CHAMBER OF COMMERCE TO ESTABLISH AN AMERICAN INDIAN PROCUREMENT TECHNICAL ASSISTANCE CENTER TO SERVE THE USET REGION

**WHEREAS**, United South and Eastern Tribes Incorporated (USET) is an intertribal organization comprised of twenty-six (26) federally recognized Tribes; and

WHEREAS, the actions taken by the USET Board of Directors officially represent the intentions of each member Tribe, as the Board of Directors comprises delegates from the member Tribes' leadership; and

whereas, the Minnesota American Indian Chamber of Commerce (MAICC) works to promote, advocate, and create economic prosperity on behalf of American Indian businesses, organizations, professionals, and Tribal enterprises in a global market; and

WHEREAS, MAICC works to provide contracting with American Indian businesses with state and federal agencies, private companies, and with other American Indian businesses promoting a Buy Indian Network; and

WHEREAS, MAICC goals and objectives include providing technical assistance, promoting business diversity, and marketing for Indian Country Businesses for markets in the southeast and eastern United States (U.S.), the USET Region; and

WHEREAS

MAICC is seeking \$600,000.00 from the United States (U.S.) Department of Defense (DOD)

Defense Logistics Agency (DLA) fund to establish an American Indian Procurement Technical
Assistance Center (PTAC), which will connect federal contracts with American Indian owned
businesses, securing needed revenue for Tribal economies; and

**WHEREAS,** DOD-DLA funds will require a \$200,000.00 match of in-kind or cash contributions, some of which has been obtained from foundations and other organizations; and

WHEREAS, attendees at the spring 2013 USET Economic Development and Entrepreneurship Summit in Nashville agreed there are opportunities for American Indian businesses and Tribal enterprises to flourish if supported with the appropriate resources, training, and technical assistance for gaining contract business; and

WHEREAS, USET has established goals and objectives to develop resources which will assist its membership with gaining technical assistance, support services, marketing, and promoting Native business to business and buy American Indian initiatives to establish robust economies; and

WHEREAS, USET wishes to establish a working partnership with MAICC in order to establish resources which will enable its Tribal membership to seize opportunities to build their local economies; and

WHEREAS,

in December 2010, the U.S. recognized the rights of its First Peoples through its support of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), whose provisions and principles support and promote the purposes of this resolution; therefore, be it

RESOLVED

the USET Board of Directors authorizes the USET Executive Director to develop and execute the appropriate memorandum of agreement establishing a working partnership with the Minnesota American Indian Chamber of Commerce in order to develop resources that will help USET member Tribe businesses advance through the uses of technical assistance, mentoring, marketing, and support provided through the establishment of an American Indian Procurement Technical Assistance Center; and, be it further
