USET SPF Resolution No. 2018 SPF:013

OPPOSITION TO ELIMINATION OF MEDICAID "RECEIVED THROUGH" LANGUAGE

WHEREAS, United South and Eastern Tribes Sovereignty Protection Fund (USET SPF) is an intertribal organization comprised of twenty-seven (27) federally recognized Tribal Nations; and

WHEREAS, the actions taken by the USET SPF Board of Directors officially represent the intentions of each member Tribal Nation, as the Board of Directors comprises delegates from the member Tribal Nations' leadership; and

WHEREAS, the United States government has a unique trust responsibility to provide healthcare to American Indians and Alaska Natives (Al/ANs), founded in treaties and other historical relations with Tribal Nations. This trust relationship is reflected in numerous statutes, as well as upheld in federal Indian law and policy; and

WHEREAS, on June 22, 2017, Senate leadership released a discussion draft known as the Better Care Reconciliation Act (BCRA), which would repeal and replace the Affordable Care Act (ACA); and

WHEREAS, BCRA included a provision that would have eliminated the "received through" language of an Indian-specific Medicaid requirement known as one-hundred percent Federal Medical Assistance Percentage, or 100% FMAP. This requirement stipulates that 100% FMAP only be for services "received through" the Indian Health Service (IHS) or a Tribal healthcare facility; and

whereas, if enacted, the provision would expand 100% FMAP to all providers who provide services to Al/ANs, thereby increasing significant Medicaid reimbursement funding to states and non-Indian providers with no guarantee that additional funding will support the Indian Healthcare System or provide better care to individual Al/ANs; and

WHEREAS, 100% FMAP for Medicaid services "received through" IHS or a Tribal healthcare facility was enacted under the Indian Health Care Improvement Act of 1976 in order to avoid costs to states for services to AI/ANs; and

WHEREAS, the proposed provision would change over 40 years of established Indian Medicaid policy without Tribal consultation and potentially impact the coordination of care for Al/AN patients that IHS and Tribal healthcare facilities provide; and

WHEREAS, changes to Medicaid must move forward in a manner that respects Tribal sovereignty and upholds federal treaty and trust responsibilities; and

whereas, in December 2010, the United States recognized the rights of its First Peoples through its support of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), whose provisions and principles support and promote the purposes of this resolution; therefore, be it

RESOLVED

the USET SPF Board of Directors stands opposed to efforts to expand the one hundred percent Federal Medical Assistance Percentage to providers outside the Indian Health System, including the proposed provision found in the Better Care Reconciliation Act, as it would drastically decrease a vital funding resource to a chronically underfunded Indian Health System, resulting in decreased health services to American Indians and Alaska Natives.
