### **Report Summary**


The Every Student Succeeds Act (ESSA) provides tribes and states an important opportunity to advance tribal sovereignty and create positive and inclusive learning environments for Native students. Schools and Native communities must collaborate to ensure students are college, career, and community ready. As the only national organization advocating for improved educational opportunities for Native students, the National Indian Education Association (NIEA) supports and builds partnerships between Native and allied stakeholders that provide opportunities for Native students to thrive in the classroom and beyond. #### Where Do Native Students **Attend School?**



The Indian Education Act makes NY Native students eligible to receive Johnson O'Malley funding.

#### The New York Legislature sets up the Native American Education Unit

for Native students.

#### 1977

The NYSED shuts down the Native American Education Unit after relinquishing control of tribal schools.

#### 2018

The Department of Education approves the New York state plan to implement the Every Student Succeeds Act.


