BOARD AUTHORIZATION FOR USET, INC. TO CONTRACT FOR AREA-WIDE CONSULTATION AND COMMUNICATION SERVICES

WHEREAS,

the United South and Eastern Tribes, Incorporated (USET) is an inter-tribal organization comprised of 18 federally-recognized tribes; and

WHEREAS.

USET is firmly committed to the goal of advancing the health care status of Indian people to the highest level possible; and

WHEREAS.

the provisions of P.L. 93-638, The Indian Self-Determination and Education Assistance Act of 1975 and those of P.L. 100-472, The Indian Self-Determination and Education Assistance Act Amendments of 1988, clearly state that the policy of the federal government is to encourage, support, and assist Indian tribes and tribal organizations in the planning and implementation of programs for their benefit through the contracting of these programs with relevant federal agencies; and

WHEREAS.

the provisions of P.L. 100-472 further state that "the Secretary is directed, upon the request of any Indian tribe by tribal resolution, to enter into a self-determination contract or contracts with a tribal organization to plan, conduct, and administer programs or portions thereof ...;" and

WHEREAS.

the programs of the Department of Human Services, Public Health Service, Indian Health Service (IHS) are included under the provisions of P.L. 100-472; and

WHEREAS.

the IHS currently operates an Area Office in Nashville, Tennessee for the purpose of planning, conducting, and implementing health care service programs for the federally-recognized in that region, including all of the USET member tribes; and

WHEREAS.

it is the legal right and privilege, granted under P.L. 93-638 and P.L. 100-472, that the tribes served by the Nashville Area Office of IHS may choose to contract to provide the functions and programs, or portions thereof, that are currently provided by the staff of this Area Office; and

WHEREAS.

in choosing to so contract for these functions and programs, these tribes may designate a tribal organization to perform such functions and conduct such programs on their behalf,

- NOW, THEREFORE, BE IT RESOLVED THAT the USET Board directs the Executive Director to prepare and submit a proposal to the Nashville Area Office for funding under P.L. 93-638 contracting regulations for the purpose of planning, conducting and evaluating area-wide "consultation and communication" services, to include, but not necessarily be limited to training, technical assistance, regional workshops, and other consultation services as might be requested by the tribes; and
- BE IT FURTHER RESOLVED THAT the Board directs the Executive Director to act upon this proposal with all deliberate speed and to negotiate said contracting for area consultation and communication services with the IHS/Nashville Area Office.
