REQUEST THE SECRETARY OF INTERIOR TO UTILIZE ALL HIS RESOURCES TO EFFECT THE TRANSFER OF THE MICCOSUKEE TAMIAMI TRAIL RESERVATION FROM THE NATIONAL PARK SERVICE TO THE BUREAU OF INDIAN AFFAIRS WITH AN INCREASE IN THE LAND BASE

- WHEREAS, the United South and Eastern Tribes, Inc. (USET) is an inter-tribal organization comprised of twenty-one (21) federally recognized tribes; and
- WHEREAS, the actions taken by the USET, Inc. Board of Directors officially represent the intentions of each member tribe, as the Board of Directors is comprised of delegates from the member tribes' leadership; and
- WHEREAS, the Miccosukee Tribe of Indians of Florida (Miccosukee Tribe) resides on 333.3 acres on the northern boundary of the Everglades National park known as the Tamiami Trail Reservation; and
- WHEREAS, the Miccosukee Tamiami Trail Reservation is a small reservation and the Miccosukee Tribe needs more land for this reservation for its members; and
- WHEREAS, the Tamiami Trail Reservation is subject to a Special Use Permit issued by the National Park Service which expires January 12, 2014; and
- WHEREAS, the Miccosukee Tribe requested the Secretary of the Interior to transfer the land from the National Park Service to the Bureau of Indian Affairs to be held in trust for the use and benefit of the Miccosukee Tribe; and
- WHEREAS, the Secretary responded to the Tribe's request by stating he could not simply transfer the land due to a reversionary clause in the property deed which would revert the land back to the State of Florida if taken our of Everglades National Park and Congressional action is necessary for this to occur; and
- WHEREAS, the State of Florida took away the Miccosukee reservation created by the state to deed the land to the National Park Service for Everglades National Park; and
- WHEREAS, the Miccosukee Tribe contends that the state reversionary clause does not apply in this case due to this being a transfer from one type of federal ownership to another type of federal ownership within the Department of

Interior and the fact that the land was previously a State Indian Reservation.

NOW, THEREFORE, BE IT RESOLVED the USET Board of Directors does hereby support the Miccosukee Tribe's efforts to have the Tamiami Trail Reservation become a Federal Indian Reservation, increase the size of the Tamiami Trail Reservation, and further requests the Secretary to commit his resources to the extent necessary to make the transfer from National Park Service to the Bureau of Indian Affairs with an appropriate increase in the land base.
