# USET DELEGATES TO HUD FORMULA FUNDING AND NEGOTIATED RULE MAKING COMMITTEE

WHEREAS, The United South and Eastern Tribes, Incorporated (USET) is an inter-tribal organization comprised of twenty-three (23) federally recognized tribes; and

WHEREAS, The actions taken by the USET, Inc. Board of Directors officially represent the intentions of each member tribe, as the Board of Directors is comprised of delegates from the member tribes leadership; and

WHEREAS, The Native American Housing Assistance and Self Determination Act of 1996, will dramatically change the policies and procedures that Indian Housing Authorities and Tribes now utilize in their dealings with HUD in the areas of finance and management; and

WHEREAS, The USET Tribes have developed a unique and long lasting relationship with the U.S. Government; and

WHEREAS, USET is looked upon by governmental authorities as an important source of information concerning the needs of Indian people; and

WHEREAS, The Native American Housing Assistance and Self Determination Act of 1996 provides for the formation of two groups, one of which will develop a formula for the allocation of funds and the other will conduct a negotiated rulemaking process for changing language in this legislation; and

WHEREAS, It is imperative that the USET Tribes and housing agencies continue to receive funding to fulfill the housing needs of their people; therefore, be it

RESOLVED, That the USET Board of Directors hereby supports and requests the appointment of several delegates to the HUD formula funding committee and the negotiated rulemaking committee and any other advisory committees that will develop procedures and policies concerning Indian Housing needs and concern; and
