Resolution No. USET 97:46

RESOLUTION PERTAINING TO THE NEGOTIATED RULEMAKING AS SPECIFIED BY THE NATIVE AMERICAN HOUSING ASSISTANCE AND SELF-DETERMINATION ACT OF 1996

- WHEREAS, the United South and Eastern Tribes Incorporated (USET) is an intertribal organization comprised of twenty-three (23) federally recognized tribes; and
- WHEREAS, the actions taken by the USET Board of Directors officially represent the intentions of each member tribe, as the Board of Directors is comprised of delegates from the member tribes leadership; and
- WHEREAS, the Indian Housing and Self-Determination Act of 1996 requires Negotiated Rulemaking in the formulating of regulations and the formula allocation for funding; and
- WHEREAS, the United South and Eastern Tribes have appointed delegates to represent the South and Eastern region in the Negotiated Rulemaking Process; and
- WHEREAS, the time constraints for finalizing this process are not adequate nor in the best interest of the tribal communities we represent; and
- WHEREAS, it is imperative that there be legal representation for the Tribal negotiation committees to insure that Tribal interests are protected; and
- WHEREAS, a Charter has been formulated and approved by the Negotiating Rulemaking Committee that publicly acknowledges the historic government-to-government relationship existing between the United States and Indian Tribes; and
- WHEREAS, there is a need for a Professional Facilitator who is familiar with the Negotiating Rulemaking Process and who can present an accurate, unbiased record of the entire proceeding; and therefore be it
- **RESOLVED**, that the USET Board of Directors support the USET Housing Committee in obtaining the following issues:

1. Extension of the Implementation Deadline

Two methods to extend the time frame to October 1, 1998

- a. Through Congressional Action or
- b. Utilizing the Administrative Provisions of the Act

2. Independent Counsel

An Independent Counsel should either be provided by the Negotiating Rulemaking Budget or alternatively Tribal attorneys may be designated to act in an Independent Consortium.

3. Charter

Request that the Charter (described above) be signed by the HUD Secretary on or before February 26, 1997 to prevent any further delays to the Rulemaking Process.

4. Technical Amendments

Request that Tribal Leadership support the NAIHC Technical Amendments by asking for assistance from their Congressional Representatives.

5. Facilitator and Record keeping

Request that a facilitator who has experience in Negotiated Rulemaking Procedures keep an unbiased record of all the proceedings and be responsible for the timely distribution of all documentation to the Tribes.
