AUTHORIZATION TO REQUEST THE INDIAN HEALTH SERVICE-NASHVILLE AREA OFFICE TO DELAY THE POSTING/HIRING OF THE DIABETES CONTROL OFFICER UNTIL 2003 USET IMPACT WEEK

WHEREAS, United South and Eastern Tribes Incorporated (USET) is an intertribal organization comprised of twenty-four (24) federally recognized tribes; and

WHEREAS, the actions taken by the USET Board of Directors officially represent the intentions of each member tribe, as the Board of Directors comprises delegates from the member tribes' leadership; and

WHEREAS, the USET Board of Directors passed Resolution No. 2002:067, authorizing the USET organization to contract for diabetes and nutrition programs, functions, services and activities (PFSAs) on behalf of the USET member tribes; and

WHEREAS, the USET Health Information Office currently has fifteen (15) tribal resolutions from the member tribes supporting the USET organization to go forward with contracting the Diabetes Control Officer (DCO) position from the Indian Health Service-Nashville Area Office; and

WHEREAS, the USET organization has no reason to believe that they will not receive the remaining nine (9) resolutions needed to move forward; therefore, be it

RESOLVED that the USET Board of Directors requests that the Indian Health Service-Nashville Area Office delay the posting/hiring of the Diabetes Control Officer until the 2003 USET Impact Week Meeting, and where at that time the USET organization is certain that they will have the remaining resolutions needed to move forward.
