USET Resolution No. 2003:060

## SUPPORT FOR THE INCLUSION OF TRIBES IN THE USFWS LAND ACQUISITIONS PROCESS

WHEREAS,	United South and Eastern Tribes, Incorporated (USET) is an intertribal
	organization comprised of twenty four (24) federally recognized tribes; and

WHEREAS,	the actions taken by the USET Board of Directors officially represents the
	intentions of each member tribe, as the Board of Directors comprises delegates
	from the member tribes' leadership; and

WHEREAS,	the USET tribes understand that the United States Fish and Wildlife Service
	(USFWS) has been purchasing lands adjacent to tribal lands without the input
	from the proper tribal governments; and

WHEREAS,	in some cases this has led to the complete exclusion of Tribes acquiring or having
	a voice in the purchase of the property or management criteria resulting in cases
	of tribal lands becoming land locked: and

WHEREAS,	the USET member tribes strongly believe that on a government to government
	basis, Tribes should be included in all planning, coordination and purchase
	agreements and should be afforded first refusal rights on properties adjacent to, or
	of interest to the tribal government; and

WHEREAS,	tribes possess the similar standards of protection, management, and stewardship
	of the lands as does the USFWS; therefore, be it

RESOLVED	that the USET Board of Directors strongly supports efforts for the inclusion of tribal
	governments into the Land Acquisition Process, specifically on adjacent lands and
	lands of interest to said tribal governments, based on the government-to-
	government relationship and fiduciary responsibility.
