## USET Resolution No. 2008:036

## SUPPORT FOR THE MISSISSIPPI BAND OF CHOCTAW INDIANS IN THEIR EFFORTS TO SECURE FUNDING VIA THE INDIAN HEALTH SERVICE JOINT VENTURE PROGRAM

WHEREAS, United South and Eastern Tribes, Incorporated (USET) is an intertribal organization comprised of twenty-five (25) federally recognized Tribes; and

whereas, the actions taken by the USET Board of Directors officially represent the intentions of each member Tribe, as the Board of Directors comprises delegates from the member Tribes' leadership; and

WHEREAS, the Mississippi Band of Choctaw Indians (MBCI) is a founding member of the USET organization and is a member in good standing; and

WHEREAS, the MBCI operates one of only two hospitals located within the Indian Health Service (IHS)-Nashville Area; and

WHEREAS, the MBCl's hospital was constructed in 1975 and is dilapidated and in critical need of replacement; and

WHEREAS, the MBCI's hospital was built for service provision under the following parameters:

User population of approximately 3,000

Space for approximately 100 employees

· Space for two health care providers, two pharmacy staff, two dental chairs; and

WHEREAS, the MBCI's hospital is currently providing services based upon the following parameters:

User population of 8,992

Currently employs 240 staff

 Space for 11 health care providers, 5 pharmacy staff, dialysis unit, and 4 dental staff; and

WHEREAS, the MBCI's current hospital facility contains asbestos, has a flat roof that leaks, and toxic odors/fumes due to an inadequate ventilation system; and

WHEREAS, the current workload for the MBCI's hospital includes:

41,000 patient visits per year

16.852 emergency room visits per year

1,857 ambulance runs per year

27,000 pharmacy visits per year

. 9,257 dental visits per year

these numbers justify the need for double the health care provider staff and exam rooms, not taking into account future growth of the MBCI population; and

WHEREAS, the lack of adequate space and number of health care providers causes the following:

Long and unnecessary patient wait times

Long and unpreventable staff working hours

Increased risk of medical error

Deficiency of modern diagnostic equipment; and

WHEREAS, the MBCI is not likely to receive funding from the IHS Facilities Construction line item for at least the next 50 years and the current hospital facility requires replacement now; and

WHEREAS, the IHS Joint Venture program is the only other IHS funding opportunity that can assist the MBCI to achieve the goal of building a new hospital facility; therefore, be it

RESOLVED the USET Board of Directors supports the efforts of the Mississippi Band of Choctaw Indians to apply for and enter into an agreement with the Indian Health Service for the Joint Venture program to construct a much needed new hospital facility; and, be it further

the USET Board of Directors instructs the USET Executive Director to allow the Tribal RESOLVED Health Program Support staff to provide technical assistance to the Mississippi Band of Choctaw Indians in their efforts to secure funding from the Indian Health Service Joint Venture program to construct a new hospital facility.
